# ABOUT THE COURSE

---



This groundbreaking program gives leaders the knowledge and skills to provide safety leadership and guidance to others, whilst creating new criteria and procedures in accordance with regulations, rail network standards, rules and procedures. The program requires a broad range of skilled applications within the rail safety environment and demands the skills and knowledge to evaluate and analyse current practices.

Aimed at technically competent or rail-experienced individuals who have responsibility for preventative safety management, the **TLI42422 Certificate IV in Rail Safety Management** offers the capacity to exercise discretion and judgement using appropriate rail knowledge.



# WHO THIS COURSE IS FOR

---

This February 2024 program is intended for individuals involved in safety management within the railway industry.

The qualification encompasses a diverse range of proficient applications within the realm of rail safety. It necessitates the ability to assess and scrutinise current practices, establish new criteria and protocols, as well as provide leadership and guidance to fellow colleagues.

This 2nd program caters to individuals who are already employed in the railway sector and have undergone training and assessment to enhance their skills and knowledge, in accordance with their employer's agreement. It is tailored for learners holding rail safety positions, including supervisors, personnel responsible for workplace health and safety (WHS), and individuals engaged in other rail-related roles.

The initial program is limited to existing workers with a minimum of 3 years rail experience. Evidence of this will be documented through a competency conversation prior to enrolment.

## COURSE LEARNING MODULES

---

The 10 units of competency that form the program will be broken up into 5 separate learning modules, each consisting of one, or a number of units of competency that are divided into a range of lessons. These lessons will be followed by a theory-based knowledge and practical demonstration type assessment.

The five modules include:

Module 1 - Introduction to Legislation

Module 2 - Fitness for Work

Module 3 - Risk and Rail Compliance

Module 4 - Rail Safety Worker Competence

Module 5 - Rail Safety and Incident Response

This structure ensures a comprehensive approach to the subject matter, encompassing key areas of rail safety management.

# RECOGNITION OF PRIOR LEARNING

Where RPL is sought, please note that RPL recognises prior learning, it is not recognition of current competency and requires the same level of evidence as per a usual assessment pathway.

As such, RPL may be applied for through the provision of evidence that the student has sufficient and extensive industry experience in the field.





# COURSE DURATION

The February 2024 intake is a fast-track program of 10 weeks duration.

Students are enrolled for 6 months and will be given access to the Alium Works Learner Management Systems (LMS) to gain access to course material, quizzes, activities and final assessment material. Enrolment into the course will give participants complimentary access to the Alium Works Pathway Program.

During the initial 10 weeks of the course, learners will attend virtual face-to-face online theory sessions, 1 full day per week. It is expected during this period that you will spend at least 5-6 hours a week of self-study completing activities and preparing for subsequent classes.

After the first 10 weeks, learners will be provided with fortnightly 2-hour training & assessing support sessions held LIVE online with an accredited trainer & assessor that satisfies the requirements of the course delivery & assessment.

The initial 10 weeks of the training program will be the theoretical & learning delivery of the course content. We recognise that not all assessment activities will be completed during this initial 10 week learning delivery period, hence why an additional 3.5 months have been allowed for to complete all remaining theory assessments, practical activities, observations, workplace learning & self-study.

On successfully completing the training and assessment, the **TLI42422 Certificate IV in Rail Safety Management** qualification will be issued. A transcript listing all units of competency will also be issued. The qualification and units of competency are nationally recognised and provide individuals with a valuable qualification that can be applied throughout Australia. Alium Works will issue a qualification within 30 days of the final assessment being completed.
